Per EPA regulations we are required to conduct a Cross Connection Survey every 3 years. To those not familiar with cross connection, it is when a drinking water source is connected to a non-potable water source. Examples would be a garden hose submerged in a swimming pool or laying in a puddle in the yard. Should there be a sudden loss of water pressure a vacuum could be created that would pull the possibly contaminated water into your drinking water.
